General comment: A very knowledgeable, thorough and well-presented document. Sections on housing are more detailed than other sections.

Comments to specific questions are detailed below. All other questions are either supported or no comment to make

Section 2: Vision, Overall Priorities and Objectives

Question	Page	Comment
1	20	A well drafted and bold plan but a vision with without a means of delivery is a pipe-dream. Whether it is achievable across the whole district is questionable as the amount of investment required to achieve it is enormous. Currently basic infrastructure is failing, eg highways issues, drainage issues, provision of adequate services such as GP's and schools and much more.
2 and 3	25	The twin overall priorities of Green to the Core and Live well Locally are aspirational. They must include consideration of development in keeping with the existing visual landscape, particularly in the rural areas. A good list, written in rather woolly terms eg instead of writing "Providing better access" write "Providing a minimum of hourly transport links and broadband with a speed in excess of xxxxx". Again, without correct infrastructure, these are little more than aspirations. Generally it is a good strategic vision, but itl needs to be properly underpinned with policy, definitive in how it will be delivered.
4	29	Good, but needs tightening up with specifics, currently there are little or no definite actions, more a generalisation of achievement targets.

7	38	Very important to set high standards, with the intention of reaching them. With 90% of our area in the HWNL and National and International protected habitats and our potential to substantially contribute to National Carbon Sequestration targets, our standards should be higher than national ones to enable us to protect that position.

28	68	Broadly agree, if the term 'village' includes hamlet. Why are all the Live Well Locally sites around Bexhill? What about the rest of Rother.
29	68	The comment 'Active Travel England's has an overall objective for half of all journeys in towns and cities to be cycles or walked by 2030' isn't really achievable unless the intention is to create cycle lanes along the very busy A roads in the district. Not many will choose to cycle along the A28 for example, given the state of the road, the volume and speed of traffic.
30-32	72	This is an important requirement and feeds into the carbon neutral and net zero agendas, but significant amounts of money will be needed for the rural areas to allow walking or riding to local amenities. This assumes that the infrastructure exists, eg a doctors surgery without a waiting list, a school not at capacity, appropriate local shops. More care needs to be taken to provide these facilities in new developments.

Comments for the HEELA Part 2 Chapter 4 Rye and the Eastern Settlements

BRE0035

"The HEELA states that this site has potential for five dwellings and that the residential curtilage should only be extended slightly northwards, as 'development of the entire site would not be acceptable, extending into the countryside out of character with the settlement pattern and impacting on an adjacent area of ancient woodland'.

Five houses in a slightly extended area would have a very similar density to the two recent applications dismissed on appeal as being 'inappropriate for an edge of village location'.

But if the density of five houses in a slightly enlarged area is considered satisfactory, then it should be shown accurately on the map, rather than show the complete area as having potential for development. The residential curtilage should be no further from the road than the existing houses in Whiteacres Close."
